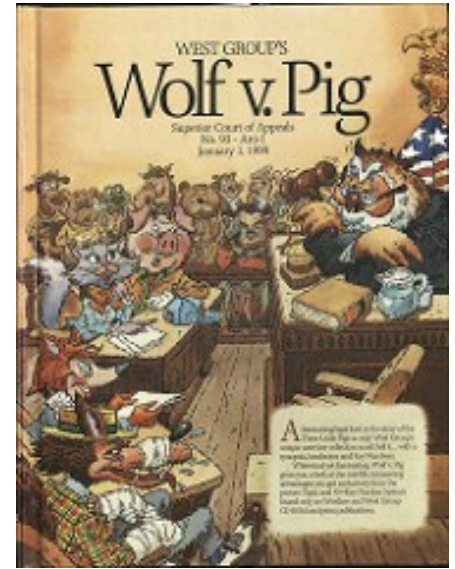
## New Yale Law Library Exhibit: "Woof, Moo & Grr: A Carnival of Animals in Law Books"

A charming exhibit of animals pictured in law books courtesy of the Yale Law Library's Rare Book collection. Titled "Woof, Moo & Grr: A Carnival of Animals in Law Books," the exhibit is narrated from the perspective of the animals themselves and is aimed at animal lovers of all ages.

Twenty books from around the world are on display, more than half of them printed before the nineteenth century and the earliest published in 1529. They feature illustrations of a wide variety of animals that visitors may be surprised to find in the pages of serious legal literature.

The exhibition is curated by Mark S. Weiner (LAW '00 GRD '99), a writer, filmmaker, and professor on leave from Rutgers Law School.

"Woof, Moo & Grr" is on display from February 1 through May 31, 2017, in the Rare Book Exhibition Gallery, Level L2, in the Lillian Goldman Law Library.
