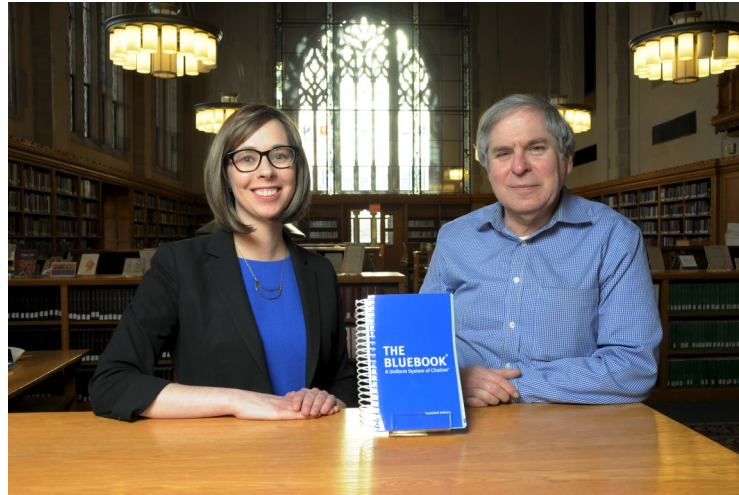


### Peter Bloomfield

## The "Secret History of the Bluebook."



The article by Fred R. Shapiro and Julie Graves Krishnaswami, "[The Secret History of the Bluebook](#)," was published in the May 2016 issue of the *Minnesota Law Review*, the 11th most-cited law review in the country. This article is the definitive history of the *Bluebook*, and demonstrates, beyond a shadow of a doubt, that the standard account of the origins is wildly erroneous and the citation manual was created at Yale rather than at Harvard. The *New York Times* covered the article in a large story in the December 8, 2015 issue. The two authors received an email, stating "Love reading about discoveries made in archival records that rewrite history. Well done!", from David S. Ferreiro, the Archivist of the United States.
