George C. Thomas III is Professor of Law at Rutgers University School of Law. He has written on various topics in criminal procedure, but has lately expanded his research into consent, coercion, rape, and pornography.

Mary Anne Case is Associate Professor of Law at the University of Virginia School of Law.

Kathy Eden is Associate Professor of English and Comparative Literature at Columbia University. She is the author of *Poetic and Legal Fiction in the Aristotelian Tradition* (Princeton University Press, 1986).

Carla Freccero is Associate Professor in the Literature Board and the Women's Studies Program at the University of California at Santa Cruz. David B. Ruderman is Frederick P. Rose Professor of Jewish History at Yale University. He has also edited *Essential Papers on Jewish Culture in Renaissance and Baroque Italy* (New York University Press, 1992) and *Preachers of the Italian Ghetto* (University of California Press, 1992).

Nancy E. Wright teaches literature at the University of Newcastle and has taught English Literature at Yale University. She is currently com-

pleting a book studying recusancy legislation in sixteenth- and seventeenth-century England.

Rogers Smith is Professor of Political Science at Yale University.

Judith Shklar was John Cowles Professor of Government at Harvard University until her death in September 1992. Her final works included *American Citizenship: The Quest for Inclusion* (Harvard University Press, 1991) and *The Bill of Rights and the Liberal Tradition* (Colorado College, 1992).

Recent books include *Law's Violence* (edited with Thomas Kearns) (University of Michigan Press, 1992) and *Narrative, Violence, and the Law: The Essays of Robert Cover* (edited with Martha Minow and Michael Ryan) (University of Michigan Press, 1992).

Barbara Shapiro is Professor of Rhetoric at the University of California at Berkeley. Professor Shapiro is the author of *Probability and Certainty in Seventeenth-Century England: A Study of the Relationships Between Natural Science, Religion, History, Law and Literature* (Princeton University Press, 1983) (winner of the North American Conference on British Studies British Council Prize for the best book in the Humanities); and "*Beyond Reasonable Doubt*" and "*Probable Cause*": *Historical Perspectives on the Anglo-American Law of Evidence* (University of California Press, 1991). She is currently working on the concept of "fact" in early modern law and science as well as on early modern political thought.

Elizabeth Fox-Genovese is Eleonore Raoul Professor of the Humanities at Emory University. Her most recent book is *Feminism Without Illusions: A Critique of Individualism* (University of North Carolina Press, 1991). She has also recently published "Feminism and the Rhetoric of Individual Rights, Parts I & II" in *Common Knowledge*, numbers 1 & 2 (1992).
