Judge Simeon E. Baldwin presented a report to the International Prison Congress at its session, September 4, in Budapest, Hungary, on the question, "By what principles and in what manner may convicts be given work in the fields, or other public work in the open air?"

The registration at the Law School shows a gain of forty students over last year's attendance.

John W. Wetzel, instructor in public speaking in the Law School, has accepted an appointment to a similar position in the Academic department of Yale. Mr. Wetzel will continue his law classes as heretofore.

Hon. Leslie M. Shaw, Secretary of the Treasury, delivered an address in Hendrie Hall, Friday evening, December 15, on the subject, "Evolution in Self-Government." The address was given under the auspices of the Law School Political Club.

Among the books recently added to the library are complete sets of Victorian Reports, Western Australian Reports, and the Kentucky Law Reporter. The St. Louis Yale Alumni Association recently presented four additional volumes of the laws and statutes of Missouri, thus completing the set which they have given the library.
